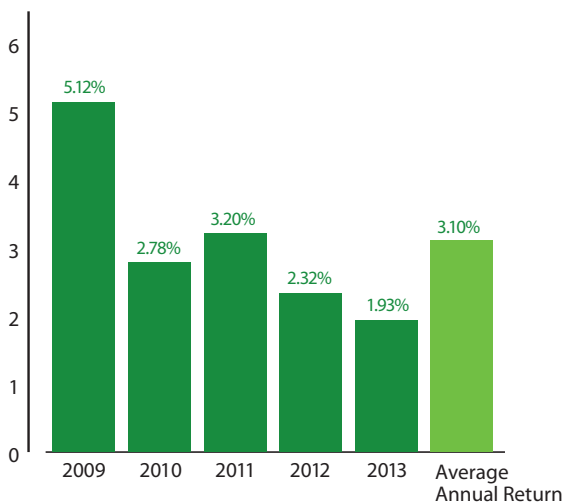

What is the purpose of this statement?

This statement provides key information about the *Mercer KiwiSaver Scheme Cash Investment Option*. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

What fees were members charged?

The returns on page one are after deductions for **fund fees**². These fees were last totalled up for the year to 31 March 2013 and were:

Each member was also charged **membership fees**³ of \$34.20 over the year to 31 March 2013.

Example of how this applies to a member

Ben had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Ben received a return after fund fees and tax were deducted of \$197.00 (1.97% of his initial \$10,000). Ben also paid \$34.20 in membership fees. This gives Ben a total return of \$162.80 for the year.


