Description of the fund

The Mercer High Growth investment option is suitable for investors seeking a growth oriented investment, who are able to withstand a higher degree of volatility in returns than can be expected from the Mercer Balanced investment option, with a view to achieving enhanced longer term returns from the 85% allocation to growth assets.

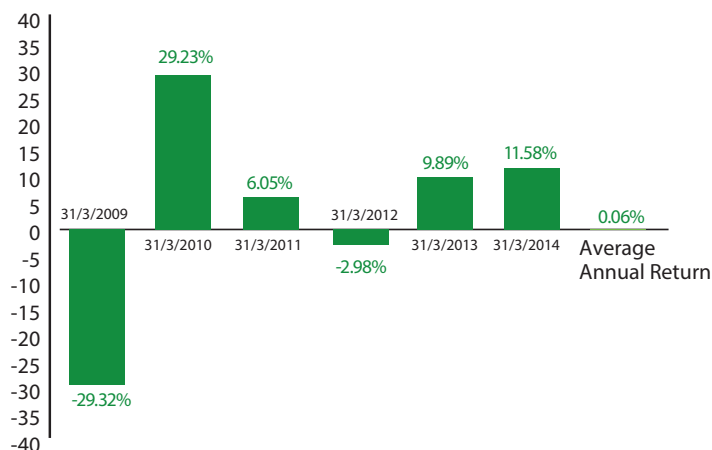
How has the fund performed?

What is the purpose of this statement?

This statement provides key information about the *Mercer KiwiSaver scheme High Growth Investment Option*. It tells you how the fund has performed and what fees it charged, and will help you to compare it with other funds. We prepared this statement in accordance with the KiwiSaver (Periodic Disclosure) Regulations 2013. This information is not audited and may be updated.

What fees were members charged?

The returns on page one are after deductions for **fund fees**². Over the past year these were:

Each member was also charged **membership fees**³ of \$34.20 over the year.

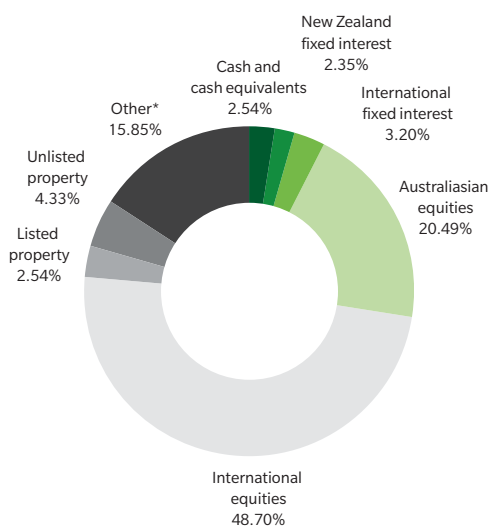
Example of how this applies to a member

Ben had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Ben received a return after fund fees and tax were deducted of \$1,158.00 (11.58% of his initial \$10,000). Ben also paid \$34.20 in membership fees. This gives Ben a total return of \$1,123.80 for the year.
