

## INVESTMENT PERFORMANCE SUMMARY AS AT 31 March 2014

Twelve investment options are available to members. Unit prices are updated weekly and reflect the investment performance of the underlying investments backing the relevant option. Earning rates are updated on a monthly basis. The table below summarises net earning rates (after tax and charges) achieved by each of these options on a monthly basis.

For comparison purposes the table below provides returns for various periods since 1 July 2013 (financial year) and for the period from 1 January 2014 (the Fund year to date).
