

## INVESTMENT PERFORMANCE SUMMARY AS AT 31 May 2018

Sixteen investment options are available to members. Unit prices are updated weekly and reflect the investment performance of the underlying investments backing the relevant option. Earning rates are updated on a monthly basis. The table below summarises net earning rates (after tax and charges) achieved by each of these options on a monthly basis.
