MERCER GROWTH FUND MERCER FLEXISAVER

This fund update was first made publicly available on: 30 November 2017.

WHAT IS THE PURPOSE OF THIS UPDATE?

This is a replacement fund update. It replaces the 30 June 2017 Mercer FlexiSaver - Mercer Growth Fund fund update first made publicly available on 28 July 2017. The following changes have been made in the replacement fund update:

- other management and administration charges, total management and administration charges and total fund charges have been updated;
- footnote 4 has been expanded to clarify the updated management and administration charges;
- the risk indicator diagram has been updated.

This document tells you how the Mercer Growth fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Mercer (N.Z.) Limited prepared this update in accordance with the Financial Markets Conduct Act 2013.

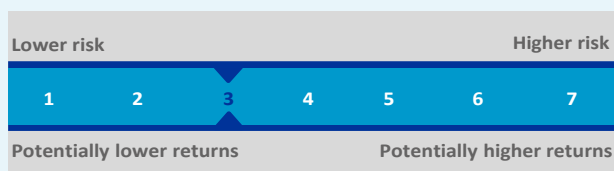
DESCRIPTION OF THIS FUND

The Mercer Growth fund invests mainly in growth assets such as shares and real assets. This may be suitable for investors wanting to invest mostly in growth assets who are comfortable accepting more volatile returns than those expected from the Balanced option with a view to achieving higher longer-term returns.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Mercer Growth fund:[†]



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a risk-free investment, and there are other risks that are not captured by this rating.

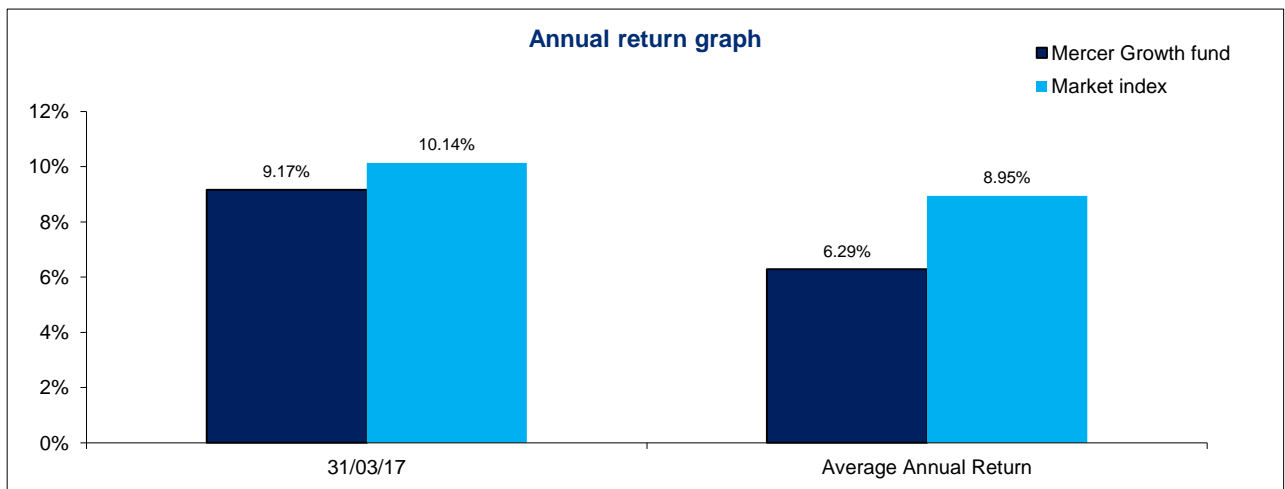

HOW HAS THE FUND PERFORMED?

This shows the return after fund charges and tax for each year ending 31 March since the fund started. The last bar shows the average annual return since the fund started, up to 30 June 2017.² Note that market indices reflect no deduction for charges and tax.

*Note: Included within 'Other management and administration charges' are performance-based fees charged by external managers of underlying funds that the fund invested into of 0.23%. Over the past five years, performance based fees have averaged 0.07% using data from similar funds Mercer manages. Performance-based fees are subject to market movements and external manager performance and the amount of these fees may differ from those disclosed for the year 31 March 2017.

These are not included in the line 'Total Performance Based Fees' as this line relates to any performance based fee paid directly to the Manager.

Investors are not currently charged individual action fees for specific actions or decisions (for example, for withdrawing from or switching funds). See the Mercer FlexiSaver scheme PDS for more information about Scheme fees. Small differences in fees and charges can have a big impact on your investment over the long term.

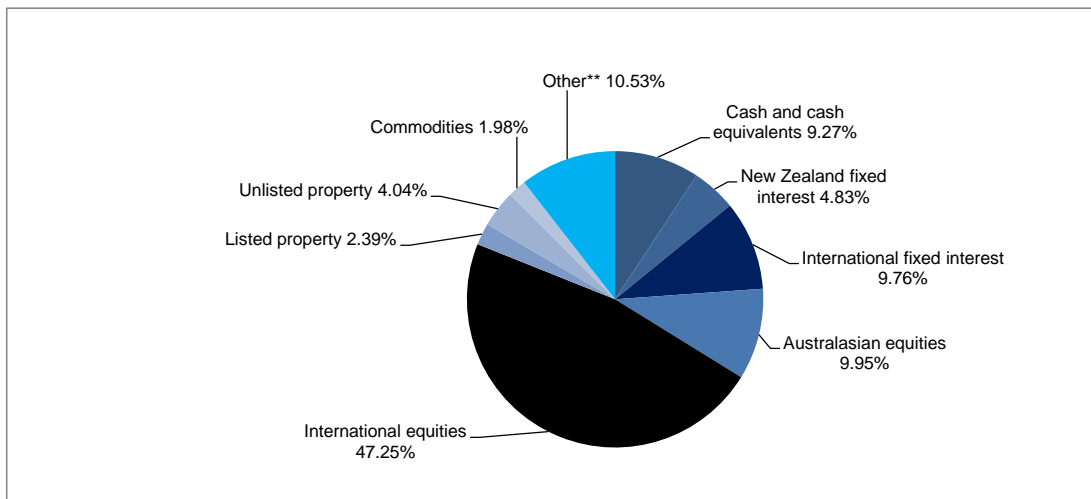
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Ben had \$10,000 in the fund at the start of the year and didn't make any further contributions. At the end of the year, Ben received a return after fund charges were deducted of \$1061.00 (10.61% of his initial \$10,000). Ben also paid \$30.00 in other charges. This gives Ben a total return after tax of \$1031.00 for the year. ⁶

Currency hedging

Currency hedging can apply to some of the asset classes this fund invests in. The level of currency hedging for global shares is managed between 0% and 100% and may change over time depending on Mercer's view of the relative strength (or weakness) of the New Zealand dollar. Other global assets classes (Global Fixed Interest and Real Assets), target a 100% net of tax hedge to the New Zealand dollar. NOTES

1. Returns may vary for some investors depending on the fund charges applicable to them.
2. The average annual return is from 30 November 2015.
3. The manager's basic fee varies for some investors including those who joined through an employer based group. Therefore, as one fee rate is not able to be used, the amounts stated have been calculated on an average basis, being the total fees incurred over the average net asset value for the year. The actual fee charged to investors may be higher or lower.
4. Other management and administration charges include the use of average charges which means that the fee applicable to some investors, including those who joined through an employer based group, may be higher or lower. The supervisor and custodian fee included in other management and administration charges has been calculated based on the unit price deduction for the year ended 31 March 2017.
5. Other charges in the form of an administration fee of up to \$2.50 per investor per month (\$30.00 per year) can apply to some investors who join through an employer based group.
6. Returns may vary for some investors depending on the fund charges applicable to them. Returns may also differ for some investors who do not incur the other charges shown.
7. For asset allocation reporting purposes cash retained for liquidity management at a sector level is assigned to the asset class to which it relates to and is not separately identified.
